  - 1. Amended and Rested Declarations of Restrictions of Oak Hills Home Owners Association, recorded April 30, 2013, as Document No. 2013-038732, including any amendments thereto ("Declaration").
  - 2. Bylaws of the Oak Hills Home Owners Association, recorded June 5, 2015, as Document No. 2015-044315, including any amendments thereto ("Bylaws").
- B. The owners and the Association wish to amend the provision in the Declaration as outlined below.
- **NOW, THEREFORE**, the Association hereby amends the Bylaws in the manner set forth below.

Page 1 – First amendment to the Bylaws of Oak Hills Home Owners Association

# I. Article V, Section 2 is hereby amended as follows:

Section 2. Annual Meeting. The annual meeting of the members of the Association shall be held on the second Tuesday of May of each year if not a legal holiday, and if such Tuesday is a legal holiday, then on the next succeeding Tuesday not a legal holiday. Written notice of each annual meeting shall be given to each member entitled to vote thereat, either personally or by mail or other means of written communication, addressed to such member at his address appearing on the books of this corporation or given by him to this corporation for the purpose of notice. All such notices shall be mailed or dispatched by the Secretary not less than ten (10) days nor more than fifty (50) days before such annual meeting and shall specify the place, the day and the hour of such meeting. Such notice shall also state the general nature of the business or proposal to be considered or acted upon at such meeting. The written proxy authorized by Article V, Section 5 herein shall accompany the notice of annual meeting prescribed by this section.
