Mandatory Training and Clearance

AQUATICS APPLICANTS

All Oak Hills Lifeguards, Pool Supervisors and Swim Team Staff are required to participate in the Oak Hills Instruction, Training, Practice and Testing days i.e. "In-service" lead by a Certified Red Cross Instructor and the Oak Hills Aquatics Manager. Training will be held on two consecutive days however, a third day for site specific training may be necessary for some or all staff. The dates and times below are mandatory and will be paid time if completed and employment is obtained. These training and testing days are considered part of the application process and any employment is not considered confirmed until this training is completed and confirmation by both the Aquatics Manager and the Certified Red Cross Instructor are obtained. A wide variety of Red Cross Guard and lifesaving skills and scenarios will be tested and drilled on land and in water.

ALL REC EMPLOYEES

All employees must pass drug tests and if over 18 years old must be willing to have us run a back ground check. If we do a run this check, it must come back clear for employment to be granted or maintained. We also may run random drug test throughout the summer.
