

HOMEOWNER SURVEY RESULTS

Thank you to everyone who shared their feedback and thoughtful insight for the 2018 Homeowner Survey. As shared at the Annual Meeting in May, the Board of Directors sought homeowner feedback on two important topics for Oak Hills: short-term rentals and prospective future HOA projects. Homeowners were asked to provide survey input only once per household, and the online survey link was communicated through email, our website, Facebook, and the HOA newsletter. We received over 325 total responses, with over 275 as qualified responses (only one survey per household),

giving the Board reliable data to use in consideration of potential action for these important topics in Oak Hills.



A few highlights:

SHORT-TERM RENTALS

Over 40% of surveyed homeowners are uncomfortable with allowing short-term rentals in Oak Hills. Homeowners believe that these types of rentals negatively impact the value of our homes, and that short-term rentals should be prohibited.

PROSPECTIVE FUTURE HOA PROJECTS

From a list of eight improvement project ideas (not including projects for general maintenance, safety, and upkeep of Oak Hills) generated by the Board from homeowner requests, installing a permanent shade structure at the pool received the highest rank in priority.

MAINTENANCE UPDATE

With safety as one of our top priorities for maintaining Oak Hills, we're removing and re-pouring sections of the concrete walkways in the greenspace and community property. There are more sections needing replacement than we have funds available in this fiscal year, so we are phasing the replacements year-to-year. The areas being replaced will be well-defined with caution tape and cones; please take caution and use other pathways during this time. The work is expected to be completed in less than 30 days from demolition to final stripping of the forms. There will be quite a bit of hand work to fill in beside the new walkways, so

please use caution while the surrounding area settles in and firms up over the next year.

Trees, trees, trees. We receive many calls concerning broken branches, dead branches, and general tree maintenance. If you note a particular hazardous condition with a tree, please send me an email (jcoleohha@gmail.com) with specific location (photographs are also extremely helpful) and we will get by to have a look as soon as possible. We are doing the best we can to manage our trees while staying within the budget allotted. Just one emergency tree incident can eat an entire year's budget in a hurry. This is something we are looking into with the next budget and considering at what rate we need to increase funding for our aging landscape.

DIRECTOR OF COMMUNITY AFFAIRS

Following a unanimous vote at the September Board of Directors Meeting, Katie Rupp is the Director of Community Affairs, a new department with the OHHA. The purpose of this department is to have a focused Board member as the primary point of contact for internal (Oak Hills HOA) and external community affairs. Katie will be responsible for representing OHHA to community organizations, such as Beaverton School District (especially Oak Hills Elementary), the West Side Trail Project, THPRD,

Bonneville Power Administration, and any other external agencies as directed. For internal Oak Hills community affairs, Katie will oversee the OHHA partnership with the Neighborhood Watch and Block Captain Programs, youth organizations (such as the Boy and Girl Scouts), Gardening Club, other local community groups as directed. Her department will have an appropriate budget with the intent of being actively involved and aware of internal community affairs. We are thrilled to have Katie

take on this new role of building relationships and acting as the primary point of contact for these groups to the Board of Directors.

NEIGHBORHOOD WATCH COORDINATOR

The Oak Hills Neighborhood Watch seeks a new Coordinator to lead this vital community program. Thank you to Nancy Robbins for her many years of service in this role. Neighborhood Watch is one of the oldest and most effective crime prevention programs in the country, bringing citizens together with law enforcement to deter crime and make our community safer. TREASURER'S REPORT

On Aug. 31, year-to-date (YTD) revenue was \$485,400. YTD expenses were \$444,700. YTD revenue exceeded YTD expenses by \$40,700. Field and Facility Rentals outperform the budget with a \$22,000 positive variance, and Aquatics and Swim Team revenues have a \$27,800 positive variance. These revenues are offset by Utilities and Equipment expenses that exceed budget by \$21,000. Project Completion is an additional expense that exceeds budget by \$3,500. Dumpster expense is \$13,000 less than budgeted. Oak Hills Homeowners Association (OHHA) thanks Roland Levesque for carefully managing this expensive asset.

With only one month remaining in this fiscal year, the Association remains in good cash position. The budget committee of Linda Marshall, Dan Badders, David Boyd and Jana Carlson is working hard on the budget for next year. Costs are being carefully controlled. We have learned that a major pool renter will not return next winter with the result that the pool may be closed during the winter months. FROM THE PRESIDENT

I am pleased to advise the Oak Hills Homeowners Association (OHHA) that we are in the process of starting the repair/replacement of some "very old" infrastructure. The first area of work will focus on the large expanse of concrete walkways that are in our greenspace. Bids have been secured and work should begin by the end of the month. While we are financially unable to accomplish all necessary repairs throughout the neighborhood at one time, you will see significant portions being replaced under the direction of Board Director Jon Cole and our Maintenance Manager, Roland Levesque.


How are these repairs to be paid for? OHHA is required by state regulation to maintain a "Replacement Reserve Fund" that over time has grown to a sizeable amount. These funds cannot be used for "Operating Costs" and are set aside every year from our annual homeowner dues. While there are a number of things that need our attention, the Board has approved the repair/replacement of greenbelt walkways as the first step. We will do our best to advise all homeowners of when/where the work will take place and ask that you "pardon our dust" during the process. Thank you.

COMPLIANCE CORNER

CORNER VISIBILITY

Many of our homeowners on corner lots need to trim the landscaping to allow proper sight lines for vehicular traffic. Vision should be unimpeded in a triangle 20 feet from the corner with all vegetation lower than 3 feet tall or higher than 10 feet tall.



DOGS

The Washington County Leash Laws apply to our common areas (Greenspace) and in the BPA Corridor. Please call Washington County Animal Services at (503) 846-7041 if you have a problem with a dog in the common areas. Thank you!

ACCESS PATHS TO GREENSPACE

Many of the greenspace access paths have been narrowed by overgrowth of vegetation or by fences erected on HOA common property. The HOA is engaged in a long-term effort to create accessible pathways the full length and width of HOA owned property. This will take time to implement and we plan to work closely with impacted homeowners, but the intent is to clear the original pathways for all of our residents to

enjoy access to our common property.

Trash cans and recycling bins should not be visible from the street.

RVs AND TRAILERS

Recreational vehicles and trailers may be parked for up to two days on the street for loading, unloading, and cleaning only. It is **never permitted** to have people dwell in the RV during this time.

REMINDER: ARB APPROVAL

Architecture Review Board approval is required for all fences, tree-houses, sheds, concrete work, exterior paint or remodeling projects. If it affects the exterior view of your property, it needs ARB approval. Failure to obtain ARB approval may result in Compliance action.

UPDATED FACILITIES RENTAL GUIDELINES

RENTAL GUIDELINES FOR OHHA RECREATION COMPLEX AND GROUNDS

(approved at the Sept. 5 Board of Directors meeting)

1. OHHA reserves the right to deny any application.
2. OHHA neither endorses nor opposes any causes, religious or political.
3. Events on OHHA property must be in keeping with the Oak Hills Recreation Mission Statement and may not be divisive, derogatory, unkind, or alienating.
4. Religious and political events that involve profiting or promotion are not allowed. This includes but is not limited to: support for or against a political candidate, measure or cause; OR support for or against any religious belief, opinion or cause.

5. If an event is denied, the applicant may appeal to the Recreational Director who will present the application to an ad hoc recreational advisory committee including at least three board members. The decision of the committee is final.

I. CALL TO ORDER/COMMUNITY ANNOUNCEMENTS

A quorum of Board members was established, and the meeting was called to order at 7:00 PM.

II. APPROVAL OF PREVIOUS MEETING MINUTES - August 1, 2018

MOTION: Lindsay Sandor made a motion to approve the August 1, 2018 meeting minutes as published in the newsletter. Linda Marshall seconded and the motion carried 7 in favor, with Martin Hehman abstaining.

III. BOARD DEPARTMENT UPDATES

No reports were given. Reports will be published in the next newsletter. The Board will revert to formal department reports at the next meeting.

IV. OWNERS' FORUM

A homeowner who has been a member of the Oak Hills Garden for five years collected extra food for Oregon Food Bank and discussed the Garden. There are 32 plots in the garden and it is estimated that over 150 people benefit from the garden. They also brought a sample of fruits and vegetables grown in the community garden. Sheila Brewer asked if they would be interested in helping to organize a small farmers market.

Spencer Barret spoke as a representative of the scouting program. He is working with Christina Matousek to reserve space in the Recreation Center for Scouting meetings and events. The Oak Hills Scouts program has been in existence for over 50 years and serves boys and girls from Kindergarten through High School. Spencer also spoke about projects that Scouts have done in the community, including Eagle Scout projects that have happened in Oak Hills. Upcoming projects include Fall Food Collection, Goodwill Collection. Scouting helps communities, and support from community through the use of the Recreation spaces is invaluable to the organization. They are asking for a discount in rental fees for the Community Room. Sheila Brewer gave a history of how Spencer's group has been able to use the facilities for free in the past in exchange for their volunteer assistance during community events; right now, multiple groups are asking for the space for free and tying up the use of the Community Room on multiple nights each month. Discussion followed on how to balance the requests and keep the process fair for everyone.

A homeowner asked the Board to confirm that when Scouts have rocket launches on the field, they have a key to the tennis courts to retrieve the rockets, and addressed the Board regarding short term rentals, recommending the Board consider limited rentals to a minimum of 90-day leases, acknowledging it would require a vote of the members. Homeowner believes that the use of the pool facilities would get out of control if association "allows" short-term rentals, such as AirBnB.

A homeowner reported a dead limb in one of the oak trees in the greenspace. He asked for maintenance to do something about it and John Cole noted that the Board is soliciting bids for community-wide tree trimming.

V. DISCUSSION TOPICS / OTHER BUSINESS

A. New ARB Member Presentation and Vote

David Boyd reported that the ARB is recommending appointment of Rebecca Leibowitz be appointed to the committee. Rebecca was an original ARB member and has practical experience in architecture; she specializes in architectural rendering.

MOTION: David Boyd made a motion to appoint Rebecca Leibowitz. Sheila Brewer seconded and the motion carried unanimously.

B. Rental Policy

Sheila Brewer reviewed the rental policy from the last meeting.

MOTION: Sheila Brewer made a motion to accept the policy as presented at the August meeting. Linda Marshall seconded. Discussion followed about adding language about adjustments to fee schedule. The motion carried unanimously without changes.

C. Director of Community Affairs

Dan Badders stated that Katie Rupp will take on a position called Director of Community Affairs. This position acts as a liaison between the association and outside agencies. Within the community the position would be a single point of contact for various entities with questions or concerns, and she could become an advocate for owners to the board. Discussion involved types of calls she would take and what types of calls should go to the police or outside agencies.

D. Fiscal Year 2018-2019

Dan Badders made the following statement regarding preparation of the 2018-2019 budget:

The Board is in the process of developing a budget for the upcoming fiscal year starting October 1, 2018. Due to increased operating costs, such as utilities and reserve funding, and a sharp drop of income from pool rentals by outside teams, initial data shows that planned expenses would exceed projected income if no changes are made. Seeing these trends, the Board will be reviewing where it makes sense to make cuts in services and general operations in order to minimize the possible budget shortfall. This is to make you aware of some change in operations that may occur in the coming fiscal year. The final 2018-19 budget plan will be completed mid-October and shared with the community at the following Board meeting.

The board confirmed for CMI that the annual assessment is \$550. CMI will mail single pay billing statements in early October, with annual payment due December 1, 2018.

Discussion about progress of budget progress included how Sheila Brewer, Recreation Director envisions the grouping of payroll categories in the budget while maintaining the detail in payroll records and the Board members each presented their opinions and ideas about this.

E. RV Lot Improvements

Martin Hehman spoke about previously approved improvements to the RV Lot; including gate opener and slats.

MOTION: David made a motion to authorize the expense of \$17,500 for gate opener, security system, etc to be paid from operating funds. John Cole seconded, and the motion carried unanimously.

VI. ADJOURN TO EXECUTIVE SESSION

MOTION: Dan Badders moved to adjourn to executive session at 8:42 pm to discuss personnel and contract matters. Martin Hehman seconded, and the motion carried unanimously.

VII. RECONVENE AND ADJOURNMENT

MOTION: With no further business to conduct, the meeting adjourned at 9:40 pm.
